This STALLION SERVICE CONTRACT AGREEMENT for the breeding season of _____, is entered into on _____, by and between Triple H ranch, hereinafter designated as Breeder, and _____, hereinafter designated as Mare Owner. Mare Owner agrees to breed the mare _____ REGISTRATION # _____ to Duns of Impact – AQHA #4326732, and are subject to the following conditions:

1. Mare owner agrees to pay a stallion service fee of \$_____. This fee is payable when the mare arrives at the breeding facility, or prior to the shipping of semen. A deposit may be required for initial booking. The mare will not be released until all veterinary expenses, board, mare care, or any other charges incurred on behalf of the mare have been paid in full.
2. Breeder agrees to diligently attempt to settle Mare Owner's mare. Mare Owner agrees to give Breeder ample opportunity to settle the mare by having her bred through at least two heat periods. If, however, for any reason, the mare does not settle, Mare Owner will hold Breeder harmless. The above applies to the normal breeding period, which is understood by both Parties to be from February 1st to July 1st of the year involved, and both Parties hereby acknowledge and agree that any mare bred during this period will be considered as having been bred under the terms and conditions of this stallion contract for that year.
3. It is further agreed that should the Mare die or become unfit to breed the Mare Owner may substitute another Mare for this or the following breeding season only.
4. Mare Owner agrees that neither Jeremy or Jasmine Helzer, or any agent of Triple H Ranch will be responsible for any sickness, accident, disease, or death to Mare Owner's mare or foal, whether the foal is with her upon arrival or foaled at the Facility. The Mare Owner will likewise not be responsible for any sickness, accident, disease, or death to the Stallion.
5. In order to protect the health program at the Facility, it is required that all mares be immunized for tetanus, sleeping sickness, influenza and possess a 6 month clear coggins prior to their arrival at the Facility. Breeder reserves the right to refuse, or quarantine at the Mare Owner's expense, any mare who they deem as a health threat to other horses at the Facility.
6. Mare Owner agrees that the Breeder may procure the services of a veterinarian, as they deem necessary, at the Mare Owner's expense.
7. Breeder offers a live foal guarantee "Live Foal" is defined as a foal that stands and nurses without assistance after birth. Breeder must be notified within 7 days that the foal did not stand and nurse, or that no live foal will be produced from Mare Owner's mare. Either statement must be under signature of a veterinarian on his or her own letterhead. Mare Owner then has the privilege to return her for the breeding during that or the following year.
8. The Mare Owner agrees to pay per day for mare care \$5.00 dry mare or \$8.00 wet mare. Breeder will have a necessary lien for all fees, charges and expenses in full. Mare Owner shall be responsible for any attorney fees and/or court costs to collect the same, if necessary.
9. The mare's registration certificate or a copy thereof must be furnished to Breeder with the signed contract.
10. Transportation of said mare is the responsibility of the Mare Owner.
11. It is the responsibility of Mare Owner to have the Mare preg checked within 60 days of the last breeding date and must notify Breeder if mare is not in foal in order to retain rebreed privileges.
12. A Breeder's Certificate will be issued for the foal, conceived by this mating, when the stallion service fee and all other expenses have been paid in full and when the mare has produced a live foal by this mating.
13. Mare Owner will read, complete, and sign this contract. This contract is not transferable or assignable. No cash refunds will be given. This contract is entered into the State of Nebraska and will be interpreted and enforced under the laws of that State. This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. Each party will individually initial additional conditions.
